# Convenor's message

Dear A4 member,

Greetings for the summer season. For most of us, this is a time of very mixed emotions as Christmas comes in the middle of a period of major transition.

My observations of Christmas for children with ASD make me aware that they vary enormously in their response. When my son was young, Christmas meant nothing to him. He would easily give up on presents if the wrapping was too difficult. New toys didn't excite him much — he preferred old familiar toys. So people who did not know him well and had tried very hard to get him something special were visibly disappointed by his response. And as parents, we were disappointed that he was not experiencing the joy of these occasions.

Now he is older, he loves Christmas and all it brings. There was a period when we could not place presents under the tree without their being opened prematurely. We got over that. We still have to remind siblings to put delicate presents away to avoid getting damaged through rough treatment or disassembly.

These days, our Christmas is for all our kids. Maybe we target our non-ASD children and include kids with ASD giving them every opportunity to enjoy it. It seems easier now than it was in the beginning. We don't need to plan ahead and prepare for the event to the same extent as we once did; and I don't think we've just become used to it.

So I hope you have a great Christmas. If you are new to all this, and feel overwhelmed at present, look to a brighter future. I hope you pause to appreciate all the positives after it is over.

Thanks to Don Randall MP from WA whose actions have given A4 a meeting with Tony Abbot MP, the Health Minister, early in 2005. Also, the Australian Institute of Health and Welfare released a bunch of new reports (see <a href="http://www.aihw.gov.au/publications/index.cfm/subject/7">http://www.aihw.gov.au/publications/index.cfm/subject/7</a>) that provide new quotes and more opportunities to increase awareness of ASD. Maybe Christmas came slightly early for A4!

A task for A4 in 2005 is defending parents of children with ASD from attacks on their parenting skills. For example, ACT and Victorian state governments, rather than tackle ASD, started programs in 2004 targeting parenting practice – thus reviving an insulting, prejudiced and outdated view that ASD is due to suboptimal parenting. But parenting practices do not cause ASD. By the 1960s people saw many siblings of children with ASD are not disabled, and disabled siblings vary widely, despite sharing the same parents. The "poor attachment" or "refrigerator mother" theory of autism was discredited.

Parents of children with ASD already address their responsibilities and obligations thoroughly. Can parents do more? Perhaps getting information on ASD and parenting sooner will help people. But communities must recognise that parent training around ASD aims to improve parents whose skills are already spectacular. Is it practical or fair to ask that better parenting skills produce better outcomes in the absence of effective early intervention, expertise and appropriate programs for people with ASD?

Governments must do their bit to give people with ASD and their parents/carers a fair go. Parents are crucial but governments who make them responsible for meeting their child's clinical needs deny governments' part of this mutual obligation. Government cannot substitute parents for specialised professionals in supervising ASD-specific early intervention and education, in providing clinical treatment for their child's clinical disorder or to compensate for the absence of essential services.

I wish you all the best for the Christmas season.

#### PUTTING VICTORIA'S CHILDREN FIRST: A NEW AGENDA

The Premier, Steve Bracks, today announced the creation of a new Minister for Children to drive the delivery of improved services and a better start in life for Victorian children.

Community Services Minister, Sherryl Garbutt, will become the new Minister for Children and will oversee a new Office for Children in the Department of Human Services (DHS).

A new Child Safety Commissioner will also be appointed to ensure the safety and protection of Victorian children at risk.

"Victoria's children are our greatest asset and our investment for the future," Mr Bracks said. "Overwhelmingly, evidence shows investment in the early years supports families in the important job of raising happy and healthy children.

"This Government recognises the importance of the early years and has boosted funding to Victoria's child and family support system since coming to office.

"The Minister for Children will build on this investment by providing a strong voice for children and delivering more coordinated and integrated services to give them the best possible start in life."

The Minister for Children and the new Office of Children were major recommendations in the Premier's Children's Advisory Committee (PCAC) Report, *Joining the Dots: A New Vision for Victoria's Children*.

The Premier also released an exposure draft of the *Working With Children* legislation and a discussion paper for public consultation until February 25.

"This legislation will widen the bans already in place on those working with children and extend the regime for checking those employed or volunteering in child-related fields," he said.

"Compulsory police checks are already carried out on teachers and child care workers. In future, the self-employed and volunteers who have contact with children through pre-schools, schools, religious organisations and overnight camps will also be checked."

The proposed checks will consider the following information:

- Registration on the recently established Sex Offender Register;
- Convictions for sexual assault, child-related violence or trafficking or supplying drugs to a child anywhere in Australia;
- · Pending charges for sexual assault, child-related violence or drug offences and
- Serious disciplinary action by prescribed professional registration boards.

The Attorney General, Rob Hulls, said it was proposed an assessment notice allowing a person to work with children would be valid for five years.

A reassessment will be automatically triggered if a person is charged with a relevant crime.

"The checks will impact on many Victorians and we want to make sure they reflect community expectations," Mr Hulls said.

"That's why we urge everyone with an interest in the protection of our children to make submissions on the exposure draft Bill and discussion paper."

The new Child Safety Commissioner will be located in DHS and report to the Minister for Children.

Ms Garbutt said the Commissioner would implement a number of measures designed to better protect vulnerable children in the community.

Other key Government responses to the PCAC Report include:

- A permanent Victorian Children's Council to be established to provide expert policy advice to the Premier and Minister for Children;
- The new Office for Children within DHS to bring together the range of children's services provided outside school, ranging from maternal and child health, kindergartens to foster care and juvenile justice services;



- A new Interdepartmental Board to be established to bring together Secretaries of Departments to ensure better co-ordination of children's policies and services;
- New regulations for Outside School Hours Child Care and
- A new Statewide Plan for Victoria's Children to provide a blueprint for children's services from the pre-natal period to school entry right across the State.

"These new initiatives will assist the Government to effectively plan for the delivery of children's services, now and in the future, and ensure our young children are school-ready," Ms Garbutt said.

"The Statewide plan will identify gaps in the children's service system and guide future improvements to better meet the needs of children and families."

Key legislation for children is expected to be passed through the Parliament next year, including the *Working with Children Act* and the revised *Children and Young Persons Act*.
