Alpha Autism provides autism specific employment services, pre-vocational training, and adult training and support services which built upon our whole of life focus, particularly regarding adult issues. Tracel has brought to the table an extra focus on issues affecting adults with ASD.

I am particularly thankful for the personal support and commitment by Rosemary Malone who despite her workload as CEO of Gateways Support Services and as Vice President of Autism Victoria always made time to provide her valuable expertise and input.
