
I saw this in the media recently ... <u>https://www.afr.com/politics/federal/bloated-ndis-encourages-providers-to-keep-children-in-care-experts-20230904-p5e1qk</u> ... more NDIS staff daemonising autism.

The basic facts are wrong here. Yes, there may be some justification for concern ... with 8.4% of children under 7yo in the NDIS. But just under 20% of those are diagnosed Autistic according to the latest NDIS data.

The *NDIS Act 2013* defines Developmental Delay (DD), a condition that the law in Australia created. According to the latest NDIS data, DD, with GDD, are the primary disability type for 69% of NDIS participants under 7 yo (58% and 11% respectively). Under 20% of NDIS participants under 7yo are Autistic (it's a very different story in the next age range).

Many Autistic children are frequently suspended or expelled from child care and other early childhood services. They are diagnosed Autistic because those services do not meet their needs. This is more evidence of the NDIS's war on autism.

The AFR article has a misleading picture. It's worried about costs the present a figure of the number of participants. This is what the cost of the NDIS looks like by disability type.



Some of the highest cost NDIS Plans for autistic people also involve Intellectual Disability (and vice versa) but the data we're shown does not indicate that.
